ORDER

As per paper read (1), the Board of Studies, Faculty of Agriculture has recommended for modifying the methodology of examination and evaluation for the various Undergraduate programmes (2024 admission onwards) of the University, considering their syllabus change as per the recommendations of the ICAR Sixth Deans' Committee Report.

The new undergraduate courses are grouped into categories such as major and minor courses, skill enhancement courses, electives and non-gradual courses. It was proposed that, the external evaluation component may be retained only for major and minor courses, while that for other course categories, the evaluation scheme will be internal.

The Academic Council as per paper read (2) has approved the recommendations.

In the circumstances, the following orders are issued.

(1) The examination and evaluation pattern for the Undergraduate courses of the University (2024 admission onwards) is modified and approved as below.

Sl.No	Course Type
1	Theory + practical course: Mid Term (20 marks) + Progressive Assessment (15* & marks) + Final Theory (50 marks) + Final Practical (15 marks) =100 marks.
2	Theory only course: Mid Term (30 marks) + Progressive Assessment (20* @ marks) + Final Theory (50 marks) =100

	marks.
3	Practical only course: Mid Term (30 marks) + Progressive Assessment (20* @ marks) +Final Practical (50 marks) =100 marks.

* Submission of a written assignment about a topic provided by the course teacher /submission of a draft of a popular article about a topic related to the course given by the course teacher =10 marks

@ Oral presentation of a case study (group activity) related with the course /mini project=10 marks.

(or)

& Oral presentation of a case study (group activity) related with the course/mini project=5 marks.

(2) External evaluation will be conducted by the University only for the Major and Minor courses.

(3) The above examination and evaluation pattern will be applicable for the UG batches of 2024 admission onwards.
