ORDER

The Dean of Faculty, Faculty of Agriculture, College of Agriculture, Vellayani has placed a proposal before the 67th meeting of Board of Studies of Faculty of Agriculture for introducing one time re-examination in the fourth semester of Diploma in Organic Agriculture programme, without considering the maximum credit load of 32.

As per the University academic regulations, a course will be offered only once in an academic year during the semester in which it is listed in the course catalogue. The student who fails shall be allowed to register the courses as re-examination course as and when it is offered.

The above norms are found appropriate in the case of those courses for which there is an External assessment. As per paper read (1) the Board of Studies (Faculty of Agriculture) has recommended that, for all the courses where internal assessment o n l y is in practice ie, for D iploma, PG diploma, PG and PhD programmes, the student can reappear for the failed examination from the next semester onwards.

As per the provisions laid down in the University statute vide (3), the Board of Studies has the powers to make recommendations to the Academic Council, in regard to the course of study and examinations in the subjects with which it deals.

As per provisions laid down vide (4), the Academic Council have the powers to make regulations relating to the conduct of examinations and to maintain and promote standards of education.

The Academic Council as per paper read (2) has approved the recommendation of Board of Studies.

In the circumstances, in consonance with the decision of Academic Council, the following orders are issued.

For all academic programmes of the University where only Internal Assessment is the practice as an evaluation mechanism, a student can seek re-examination for a failed course from the next s u b s e q u e n t semester onwards, limiting the maximum credit load of the semester to 32.
