## **ORDER**

As per paper read (3), the Dean (Faculty of Agriculture) has placed a proposal for rescheduling of Participatory Learning Programme titled as 'Participatory Learning on Farming Situations and Extension Interventions' KBA 1201(0+1), for the BSc (Hons.) Ag. students of 2022 admission.

The above said new credit course KBA 1201(0+1), was scheduled to be offered in the Second semester of the 2022 admission Bachelor of Science (Hons.) Agriculture course and to continue in 3rd and 4th semesters, as per Order read (2) issued in compliance with the decision vide paper read (1). The course is being offered from the Department of Agricultural Extension Education.

The 67th Board of Studies, Faculty of Agriculture have recommended the proposal for rescheduling the conduct of the course, KBA 1201 (0+1) from the semesters 2, 3 and 4 to the semesters 4, 5 and 6 of 2022 admission B.Sc. (Hons) Ag. batches. It was also

and also has the powers to make recommendations in regard to the course of study and

examinations with which it details.

As per provisions laid down vide (5), the Academic Council is responsible for the

maintenance of standards of instruction, education and examination within the University.

The Academic Council as per paper read (6) has approved the proposal.

In consonance with the decision of the Academic Council, the following orders are

issued.

1. Sanction is hereby accorded to reschedule the course, "Participatory Learning on

Farming Situations and Extension Interventions' KBA 1201 (0+1) to the fourth

semester of the 2022 admission B.Sc.(Hons.) Agri. students and to continue in the

5th and 6th semesters.

2. Sanction is also accorded to offer the said course in the second semester itself, from

2023 admission BSc. (Hons) Ag batches, onwards.
