ORDER

As per paper read (1), a proposal for issuing Certificate of Experience to students on successful completion of all modules under Rural Awareness Work Experience (RAWE) & Agro - Industrial Attachment (AIA) has been approved by the Board of Studies, Faculty of Agriculture with a recommendation to place it before the Academic Council.

The Rural Awareness Works Experience (RAWE) and Agro-Industrial Attachment (AIA) programme undertaken by the undergraduate students during the VII semester with a weightage of 0+20 credit hours consists of on campus training by different faculties followed by village attachment/unit attachment in University/ College/ KVK or a Research station. Students get hands on experience at the field level under different modules like Soil Testing, NGO Training, Krishi Bhavan Training, Media Attachment, Water Shed Management, Agri-clinic, Bank attachment, EDP & Project management, Agro-Industrial Attachment, Farm Planning, Progressive Farmer attachment, Self Help Group attachment etc.

The Board of Studies has recommended to issue a Certificate of Experience mentioning the modules of RAWE programme in detail, to students who complete all the modules successfully that will indicate that the student has undergone hands on training in those aspects. The Certificate has to be issued by Deans of colleges concerned, in a common

format detailing the module and duration and mentioning it as a part of course programme.

As per the provisions laid down in the University statute vide (3), the Board of Studies has the powers to recommend to the Academic Council, the certificates to be awarded and the conditions therefor.

As per provisions laid down vide (4), the Academic Council have the control and general regulation and is responsible for the maintenance of standards of instruction, education and examination within the University.

The Academic Council as per paper read (2) has approved the proposal.

In the above circumstances, the following orders are issued.

- Sanction is hereby accorded for issuing Certificate of Experience to students on successful completion of all modules under Rural Awareness Work Experience (RAWE) & Agro - Industrial Attachment (AIA), mentioning the modules of RAWE programme in detail.
- 2. The Deans of Faculty (Agriculture, Ag. Engg. & Tech and Forestry) together will work out and finalise a common certificate format and share it with other Deans.
- 3. The Certificate (from 2021 admission onwards) wilbe issued by the Deans of colleges concerned, in this common format detailing the module and duration and mentioning it as a part of course programme.
