Eligibility required to appear for admission and Category wise vacant seats available are given below:

ELIGIBILITY

1. All professional graduates of State Agricultural Universities/Deemed Universities under ICAR system with a minimum OGPA of 7.0/10.0 (6.5 for SC/ST candidates).
2. All graduates, including professional graduates from Indian/Foreign Universities under regular stream recognized by ICAR/AICTE/UGC with minimum 60% marks from SSLC onwards under traditional system (55% marks for SC/ST candidates).
3. Candidates should have qualified KMAT/CMAT/CAT entrance exams conducted during the period from November 2024 to May 2025.

The interested candidates are directed to report **IN PERSON** on the date, time and venue mentioned above along with the following original documents, copies of documents and prescribed fee. The candidates should ready to pay fee at the time of admission.

- a. Score card of KMAT/CMAT/CAT.
- b. Proof of online payment of application fee.
- c. Degree/ Provisional Degree certificate to prove the eligibility for admission.
- d. Mark list/ Transcript of 10 th standard, Plus 2 and Degree.
- e. TC & Conduct certificate from the Head of Institution last studied.
- f. Migration Certificate.
- g. Original Aadhar card.
- h. Certificate to prove date of birth.
- i. Community certificate obtained from a Revenue Officer not below the rank of a Village Officer in the case of SC/ST candidates.
- j. Non-Creamy Layer Certificate (NCLC) in the case of SEBC candidates.
- k. Nativity Certificate issued by Village Officer for candidates from Kerala and by the competent authority for candidates from other states.
- l. Physical fitness certificate issued by a Government Medical Officer not below the rank of an Assistant Surgeon.
- m. Fee Rs.41,100/- for General candidates and Rs.13,535/- for SC/ST candidates.
- n. Students from outside Kerala should also remit a special caution deposit of Rs.3000/- (refundable).
- o. Contribution to PTA fund of Rs.1,105/- and Placement Fund of Rs.5,515/- shall be paid at the time of admission.
- p. Hostel fees, Mess advance and Establishment Charges notified by the respective

hostels to be paid at the time of joining the hostels.

- q. One self attested copy of each of the certificates mentioned in (c), (d), (g), & (h) above.
- r. Candidates who have passed the qualifying examination from University outside Kerala should produce a Certificate from the Head of Institution to the effect that the said University is recognized by the ICAR/UGC/AICTE.

Candidates who fail to report in person for admission along with the documents as specified above at the stipulated date and time or fail to remit the full fee as directed by the University at the time of admission, will lose their chance for admission without any further notice. No further claim in this regard will be considered.
