## **ORDER**

A proposal for permitting to meet the registration fee, eligible bus/train/air fare of students in connection with attending seminar/symposium etc. from the contingency grant for research work of PG/Ph.D students or ICAR Development Grant (subject to availability of funds) was placed in the 61<sup>st</sup> meeting of the Board of Studies (Faculty of Agriculture) held on 28.03.2019 and the board has decided to meet the registration fee, eligible bus/train/air fare of the students attending the seminar/symposium etc. from the contingency grant for research work of PG/Ph.D students or ICAR Development Grant (subject to availability of funds), if such seminar/symposium etc. is related to their field of study. The Dean/Associate Dean may approve the same on production of duly certified original ticket/invoice by the student concerned through Head of the Department, limited to 3 seminars for PG students and 5 for Ph.D students, during the entire period of course.

The same was placed before the 133<sup>rd</sup> meeting of the Academic Council held on 26.04.2019 for approval. The council has approved the proposal with a modification to remove the air fare from the expense for attending the seminar/symposium.

In consonance with the decision of the 133<sup>rd</sup> meeting of the Academic Council held on 26.04.2019 the following orders are issued

- 1. Sanction is hereby accorded to meet the registration fee, eligible bus/train fare of the students for attending the seminar/symposium etc. from the contingency grant for research work of PG/Ph.D students or ICAR Development Grant (subject to availability of funds).
- 2. The Dean/Associate Dean may approve the same on production of duly certified original ticket/invoice by the student concerned through Head of the Department, limited to 3 seminars for PG students and 5 for Ph.D students, during the entire period of course, related to their field of study.
